Circumstances of collection and use of your personal information

The primary purpose for which we are collecting your personal information in this webform is to facilitate your participation in, and our management of, the “Second Chance Draw” random draw to win \$5,000 in connection with the “ClubPASS Sign In To Win Competition Promotion” (the **Promotion**) and to enable us to notify you if you win the Second Chance Draw.

You agree that we may also use your personal information for related secondary purposes including:

- for any other purpose stated in our [Privacy Policy](#).

What personal information we collect

ClubsNSW will collect the following personal information from you:

- first name;
- last name;
- date of birth;
- email address; and
- phone number.

Consequences if personal information is not collected

Providing us with the requested personal information is not required by law. However, if you do not provide us with the personal information we ask for, or the information provided is incorrect or incomplete, you will not be able to participate in the Second Chance Draw.

Disclosures of your personal information to third parties

We may disclose your personal information to the following organisations for the purposes described above (as well as otherwise permitted or required under Australian law):
