Financial Performance

Tracking and evaluating financial performance enables clubs to make informed decisions about resource allocation, investment opportunities, and cost management. Regular assessment of financial statements, budgetary reports, revenue streams, and expense patterns enables clubs to identify strengths, weaknesses, areas of improvement, maintain financial stability and maximise profitability.

Citations and Regulatory Matters

By including a segment in the agenda to discuss citations and regulatory matters, clubs can address any issues promptly. This allows for the implementation of corrective actions, mitigation of risks, and adherence to regulatory requirements.



Monitoring and discussing citations also help clubs identify potential trends or recurring problems that may require systemic changes.
